Great, thanks. John and I talked briefly and I think we have pretty good cause to argue that the request is not reasonably described given that it is not limited by time or subject.

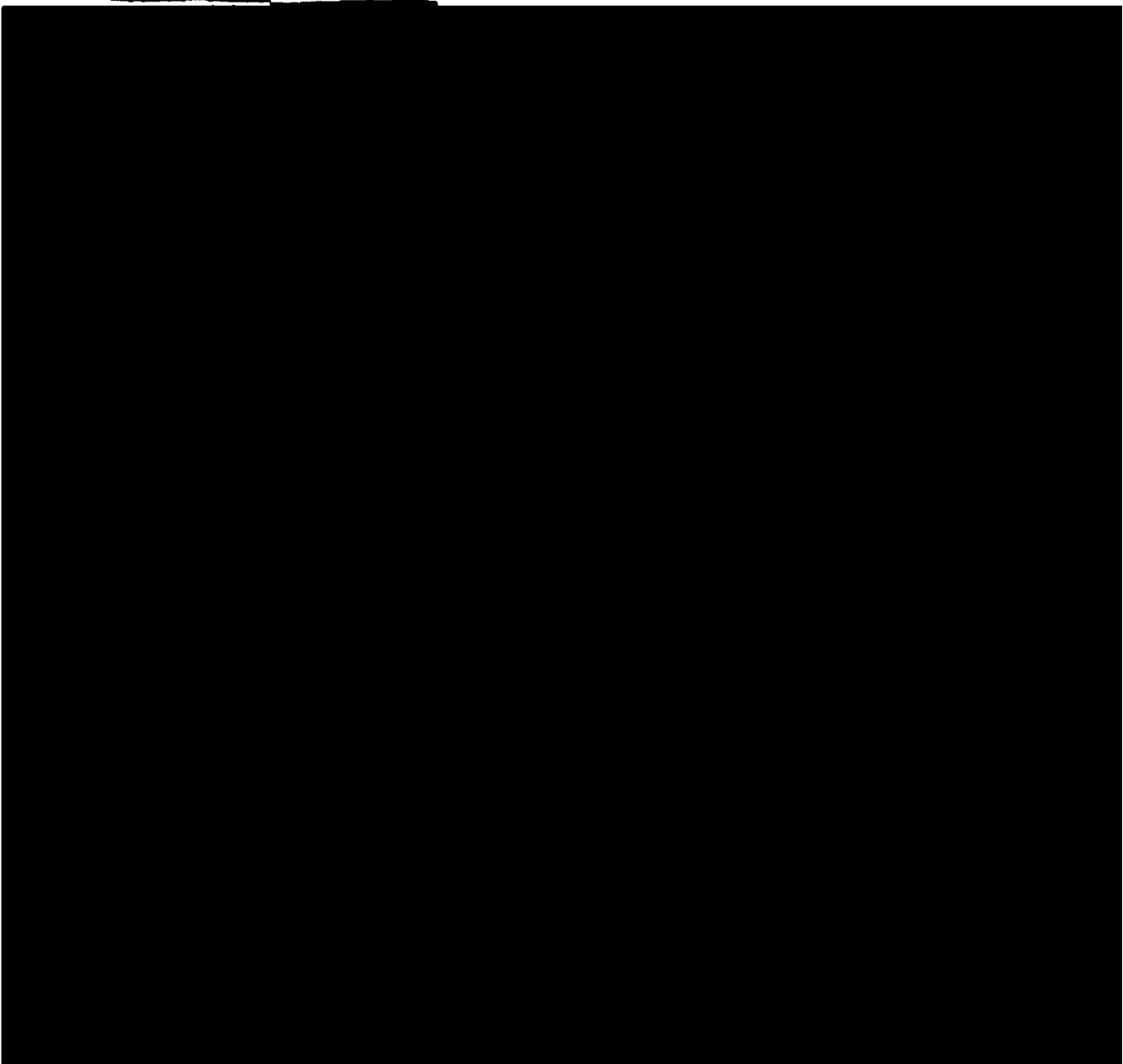
